I. General Information

A. SWACO. The Solid Waste Authority of Central Ohio (“SWACO”) is a regional solid waste authority established in accordance with Ohio Revised Code Section 343.011. SWACO was created in 1989 in response to Substitute House Bill 592 (“HB 592”) to develop and implement a comprehensive solid waste management plan for the Franklin County Solid Waste Management District, which is comprised principally of Franklin County but includes parts of five (5) adjacent counties (collectively the “District”).

As a political subdivision of the State of Ohio, SWACO operates a Subtitle D sanitary landfill with an allowable maximum daily capacity of eight thousand (8,000) tons and two (2) waste transfer stations with a combined capacity of approximately two thousand (2,000) tons per day. SWACO owns and/or leases multiple facilities and operates on an estimated fifty-one million dollars (\$51,000,000) of annual revenue and twenty-five million (\$25,000,000) of SWACO’s EPA Trust Fund.

SWACO employs approximately one hundred thirty-five (135) full-time staff who work under four (4) major organizational functions: Administration, Operations, Legal Affairs, and Innovation & Programs. SWACO also provides programs aimed at reducing the generation and disposal of solid waste within SWACO’s District. These programs include public education and awareness, yard waste composting, and other waste-reduction activities. SWACO is also responsible for maintenance activities at a closed landfill. Total solid waste generation within SWACO’s District exceeds one million tons (1,000,000) per year.

B. Board of Trustees. A nine (9)-member Board of Trustees (“Board”) governs SWACO. Pursuant to Ohio Revised Code Section 343.011 and SWACO’s bylaws, the Mayor of the City of Columbus and the Franklin County Board of Commissioners each appoint two (2) members to the Board. Other members include one (1) designee of the Franklin County Health Commissioner, one (1) designee of Franklin County’s Township Trustees, and three (3) members appointed by the Board representing the public, general interest of the citizens, and the industrial, commercial, or institutional generators of solid wastes within the District. The Board appoints SWACO’s Executive Director, who serves as SWACO’s Chief Executive Officer.

II. The Project

A. Project Description. Project Services include providing all necessary equipment, labor, office support, and overhead activities to provide SWACO with various general engineering services such as civil, electrical, mechanical, structural, regulatory reporting, and other site-specific environmental related items as needed at SWACO’s facilities. Please see SWACO’s Locations as listed in Exhibit A of the RFQ Documents.

B. Project Objective. SWACO is seeking qualified Proposers that can provide a team of personnel, including subcontractors, that are capable of assisting SWACO with any, some, or all the engineering services as described in the RFQ, as requested by SWACO, and during a three (3)-year period (2027-2030). The Project expectations and details are described in the Scope of Services.

C. Scope of Services. SWACO has developed a Scope of Services, *Exhibit A*, for the purposes of seeking Statements of Qualifications for the Project. The listed services may

be further developed and refined during the evaluation process and the negotiation of any contract that may be awarded to a Successful Proposer, if any. The final Scope of Services for the Project may include any, all, or none of the elements as contained in Exhibit A.

D. Required Forms and Documents. Section III, Subsection C, provides a list of *Required Forms*, attached hereto as ***Exhibit B***, for this RFQ. All Required Forms are to be filled out in their entirety, notarized when applicable, and included with the SOQ. Proposers must also include a copy of their Certificate of Insurance with the SOQ submission.

E. Sample Contract. A sample contract is provided, attached hereto as ***Exhibit C***, setting forth the proposed terms, conditions, provisions and/or specifications, which shall govern the relationship of SWACO and the Successful Proposer, if any, upon the award of a contract for the Project.

F. Exceptions to RFQ. Any exceptions to this RFQ will be considered and included in SWACO's analysis. If Proposer fails to list any exceptions, SWACO will assume compliance with the terms, conditions, and requirements of the RFQ, including the Sample Contract, and Proposer shall not raise any exceptions later if selected for award. Please see Exhibit B, Required Forms and Documents, for the RFQ Exceptions Form. The following exceptions shall not be granted:

1. Any limit of the liability of Proposer for any direct damages;
2. Any reduction to the required insurance Proposer must carry for the Project;
3. Any request by Proposer to limit its indemnification of SWACO stated in Section VI(G)(1) below;
4. Any requirement that SWACO indemnify Proposer;
5. Any request for arbitration; or
6. Any request for the contract to be governed by the laws of a jurisdiction other than Ohio, or a request for a venue other than the courts of Franklin County, Ohio.

G. Times. All times set forth in this RFQ are listed at Grove City, Ohio local time, which is Eastern Standard Time (EST).

H. Timeline of Events. The following is the schedule of events concerning the submittal and consideration of Statements of Qualifications and the award of the contract to the Successful Proposer(s). All dates listed may be altered at SWACO's sole and complete discretion.

I. Definitions. For purposes of this RFQ, the words, terms, and phrases set forth below shall have the indicated meanings. Any other terms, words, or phrases herein shall have their ordinary meaning.

1. *City* means, "municipal jurisdiction in which the work is performed,

including but not limited to the City of Columbus, Ohio and City of Grove City, Ohio, as applicable to the work location.

2. *FCSL* means the “Franklin County Sanitary Landfill.”
3. *JPTS* means the “Jackson Pike Transfer Station.”
4. *Model Landfill* means the “closed landfill located on Jackson Pike, which was the former Phoenix Golf Course.”
5. *MRTS* means the “Morse Road Transfer Station.”
6. *Project* or *Services* means, “providing general engineering services as described in this RFQ.”
7. *Proposer* means “a person or organization submitting a Statement of Qualifications.”
8. *RFQ* means “Request For Qualifications.”
9. *Sample Contract* means “the sample contract provided by SWACO to potential Proposers setting forth the proposed terms, conditions, provisions and/or specifications which may govern the relationship of SWACO and the Successful Proposer, if any, upon award of the contract for the Project.”
10. *SOQ* or *Statement of Qualifications* means “the written response to this RFQ, including, without limitation, any modifications or revisions thereto, submitted pursuant to the terms, conditions and provisions set forth in this RFQ.”
11. *Successful Proposer* means “the Proposer(s) with which SWACO negotiates and enters into a contract as a result of the process set forth in this RFQ.”
12. *SWACO* means the “Solid Waste Authority of Central Ohio.”

III. SOQ Format and Requirements

A. SOQ Format. SOQ submissions must be electronically uploaded to SWACO using the link provided in Section IV below.

B. SOQ Requirements. Each SOQ must contain the information requested in this Section III to be considered a responsive Proposer. SOQs should be no more than thirty (30) pages, not including resumes and required documents. SOQs should also be assembled in sequential order of the requested information, including and without limitation, information regarding the following:

1. ***Brief Narrative***. A brief narrative describing the Proposer and its personnel, any subcontractors that will be on the Project and their personnel, and Proposer and subcontractor experience. Please limit the *Brief Narrative* to no more than three (3) pages. Brief narratives that contain sections simply relying on references to attachments or appendixes will not receive consideration.
2. ***Description of the Proposer*** – The Proposer’s background, including a brief description the organization, date founded, and ownership of the Proposer (e.g., past history, present status, future plans, company size, years in business, number of locations, as well as the number of years operating in Ohio).
 - a) Indicate if it has experienced a material change in organizational structure, ownership or management during the past three (3) years and, if so, please describe.

- b) Describe any other business affiliations or partnerships the Proposer currently has in place that may impact Proposer in providing the Project.
- c) Disclose any employees who were previously employed at SWACO within the last two (2) years**.

** For every employee disclosed, please provide the date he/she was hired, a detailed explanation as to how the Proposer will prevent the employee from participating in this Project, and an affirmation from the employee that he/she will not disclose confidential information acquired in the course of his/her employment with SWACO.

3. *Proposer's Minimum Qualifications and Experience* – Proposers should be able to demonstrate their experience providing similar services through references. Provide a brief description of the Proposer's qualifications and experience for performing the Scope of Services, and without limitation, information regarding the following:

- a) A list showing at least five (5) client references demonstrating five (5) years of experience for which the Proposer has provided similar services to those listed in the Scope of Services (Exhibit A).
 - Provide contact information for those references that may be contacted by SWACO.
- b) Include any experience and references with the government segment.

4. *Proposer's Personnel and Subcontractors*. Include a list of all persons that will be assigned or employed on the Project by the Proposer. In addition, the SOQ shall also identify:

- a) Background information on Proposer's key person or project manager who will be taking the most active role(s) in the Project.
- b) Resumes and biographical information must only be provided on key members of the team that will be directly involved in the Project. Please do not include resumes of personnel that will not be a key member of the team.
- c) A description of their experience on similar projects, including the number of years at the Proposer's organization, any professional licenses and designations, and a list of references that may be contacted.
- d) A narrative of the Proposer's training and education efforts to keep Project personnel informed of progress and any relevant Project changes.
- e) Any subcontractors and their assigned roles that may be employed by the Proposer on the Project. Provide best estimate for percentage of the subcontractor's responsibility for assigned role.

5. *Approach to the Project* – Provide a detailed project plan setting forth the manner in which you are proposing to deliver Services, including objectives, milestones, communications, how any changes will be implemented, and any information or decisions required of SWACO.

- a) Briefly describe any additional features, attributes, or conditions which SWACO should consider in the selection process.
- b) Provide any other information that Proposer feels applicable to the evaluation of their qualifications for providing the Services. Use this section

to address those aspects of the Proposer's services that distinguish it from others. Additional information shall be considered when evaluating.

C. Required Forms and Documents. SOQs must contain the following Required Forms, attached hereto as ***Exhibit B***, which must be filled out in their entirety, executed, and included with the SOQ:

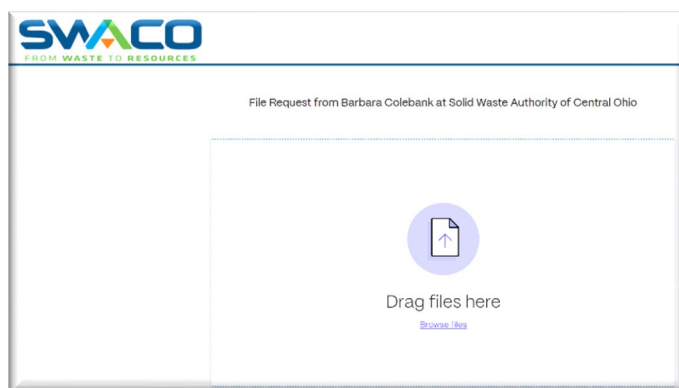

IV. Submitting the SOQ

A. Submittal Information. All Statements of Qualifications must be uploaded electronically in a PDF document and titled, "**Proposer's Name – General Engineering.**" ZIP FILES ARE NOT ACCEPTED. Please include Proposer's name to the file name(s) and upload to the following link:

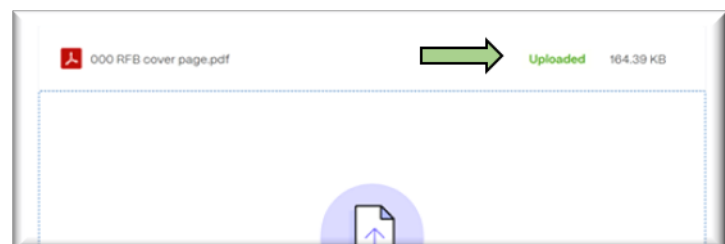

B. SOQ Documents. All submitted responses to this RFQ **must be uploaded to the link provided no later than 1:30 p.m., October 9, 2026**. All SOQs will be time and date stamped upon successful upload and shall be considered the official time and date of receipt by SWACO.

C. SOQ Submission. It is the sole responsibility of the Proposer for the uploading of its SOQ to the link provided prior to 1:30 p.m., October 9, 2026.

1. Failure to submit SOQs electronically as instructed above in paragraph A. shall not be considered a valid submission to SWACO.

2. **Paper documents, facsimiles, emails, or any other mode of transmission other than that stated above shall not be considered as a valid submission.**

3. SWACO is not liable for non-submission and/or late submission of any SOQ response due to a Proposer not having correct information.

4. A submission to this RFQ shall be considered evidence that the Proposer has examined and is satisfied as to the terms, conditions, provisions, specifications and/or requirements for the Project described in the RFQ Documents. If Proposer does have exception to the RFQ Documents, those exception(s) are outlined in the RFQ Exceptions Form in Exhibit B.

5. No pleas of ignorance of any of the terms, conditions, provisions and/or specifications set forth in the RFQ Documents shall be accepted as a basis for any claim for an increase in the amount by a Proposer or an extension of the times set forth in the RFQ Documents.

D. SOQ Preparation Costs. Proposer shall be liable for all costs or expenses related to investigating, preparing, and submitting a SOQ in response to this RFQ as well as any costs or expenses related to the negotiation and award of any contract resulting from this RFQ.

E. Termination of RFQ Process. At any time prior to the execution of any contract awarded pursuant to this RFQ by SWACO's Executive Director, SWACO may terminate the process set forth in this RFQ for any or no reason.

V. RFQ Questions, SOQ Modifications, Withdrawal, and Opening

A. Proposer Requests for Information and Addendums. Requests for information from a Proposer shall be submitted in writing only to SWACO Procurement via e-mail at procurement@swaco.org. **Any and all such requests must be received no later than 4:00 p.m., October 2, 2026**. SWACO shall respond to any properly submitted request for information by a written addendum issued to all Proposers who have obtained an RFQ packet for this Project. In addition, SWACO, on its own initiative, may issue such other addenda as it may deem appropriate from time to time. No request for information shall be considered answered by SWACO until SWACO has issued an addendum in response to such request for information, and copies of the written request for information and SWACO's response has been issued to each Proposer. Upon receipt of any addendum, Proposers shall notify SWACO in writing of its receipt of the addendum by completing the *Addendum Acknowledgement* form in Exhibit B, *Required Forms*, and submitting with the SOQ.

B. Modification of SOQ. At any time prior to the opening of SOQs, a Proposer may modify its SOQ in writing by submitting a modification marked in the same manner as the original SOQ via electronic upload to SWACO at the link set forth in this RFQ. Any such modification must be received by SWACO prior to the opening date and time of the SOQ to be considered effective.

C. Withdrawal of SOQ. Prior to the opening of SOQs, a Proposer may withdraw its SOQ provided the Proposer makes a written request to withdraw the SOQ. Such request must be received by SWACO Procurement at the email address indicated above in paragraph A prior to the opening of SOQs at 1:30 p.m., October 9, 2026. The written request to withdraw must be executed by a party authorized to execute the SOQ, include an executed Affidavit of Authority, and be emailed to SWACO. Any properly withdrawn SOQ shall be returned to the Proposer unopened.

D. SOQ Opening. All SOQs received by 1:30 p.m., October 9, 2026, shall be electronically opened. The list of Proposers that submitted SOQs will be distributed to those who downloaded the RFQ Documents. **No other information will be released at the time of the opening.**

E. Rejection or Waiver of SOQs. SWACO may, in its sole and complete discretion, reject any or all SOQs, waive any irregularities contained in an SOQ, or terminate the process set forth in this RFQ at any time if it is determined in the best interest of SWACO to do so. Solicitation and opening of any SOQ submitted in response to this RFQ does not create any express or implied obligation of SWACO to enter into any contract.

VI. Standard Terms and Conditions

A. Budgeting. All budgets are subject to the annual appropriation of funds by the SWACO Board of Trustees.

B. Taxes and Payment. The Proposer is hereby notified that:

1. SWACO is a Political subdivision pursuant to ORC Section 343 and exempt from State sales or use taxes. Therefore, such taxes shall not be included in any rate or price quotations submitted; and
2. SWACO does not pay retainers, deposits, or make any other advance payments prior to services rendered.

C. Contract Termination. SWACO's standard contract termination is at least fifteen (15) days in writing prior to the date of the intended early termination of the Proposed Contract.

D. Invoicing. Invoices must be submitted to SWACO within sixty (60) days after Services have been rendered and such invoice(s) received shall be paid within thirty (30) days of its approval by SWACO.

E. Additional Fees. Notwithstanding any term, condition, or provision set forth in the SOQ, SWACO shall not be obligated or liable to the Successful Proposer and/or any other party for any late payment, collection costs, fees, and/or interest charges.

F. Indemnification and Insurance. Each Successful Proposer is advised that in addition to any other terms, conditions or provisions that may be contained in any contract awarded and executed as a result of this RFQ (including without limitation warranty

provisions), the Successful Proposer shall agree to the following indemnification and insurance provisions:

1. *General Duty to Indemnify SWACO.* The Successful Proposer shall indemnify and hold harmless SWACO, its trustees, officers, employees and representatives from and against all claims, damages, losses, liens, causes of action, suits, judgments, and expenses (including reasonable attorney's fees and other reasonable costs of defense), of any nature, kind or description, which (a) are caused by or result from the performance of the Services by the Successful Proposer, anyone directly or indirectly employed by the Successful Proposer, any sub-contractor of the Successful Proposer, or anyone for whose acts the Successful Proposer is legally liable, and (b) are attributable to bodily injury, personal injury, sickness, disease or death of any person, or to damage to or destruction of property, but (c) only to the extent they are caused by any negligent, reckless or willful act, error or omission of the Successful Proposer, anyone directly or indirectly employed by the Successful Proposer, any sub-contractor of the Successful Proposer, or anyone for whose acts the Successful Proposer is legally liable. The terms and conditions of this paragraph shall survive termination of this contract for any reason.

2. Successful Proposer shall promptly correct, repair, and/or replace any part, work, supplies and/or other materials installed as part of the Services and damaged and/or destroyed as a result of an insured loss or damage. Such correction, repair and/or replacement shall be the Successful Proposer's sole responsibility and shall be undertaken and completed at no additional cost to SWACO.

3. **PLEASE NOTE: THE GENERAL DUTY TO INDEMNIFY SWACO IS NOT NEGOTIABLE. IF YOU ARE UNABLE TO AGREE TO THE PROVISION SET FORTH ABOVE, SWACO WILL BE UNABLE TO ENTER INTO A CONTRACT WITH YOUR COMPANY.**

4. *Liability Insurance.* The Successful Proposer shall purchase and maintain the following liability and other insurance at the indicated limits, under the terms set forth below:

a) *General Liability Insurance*, containing the following limits and terms:

- (i) \$1,000,000.00 per occurrence
- (ii) \$2,000,000.00 aggregate
- (iii) \$1,000,000.00 Products/Completed Operations Aggregate
- (iv) Name SWACO as an additional insured
- (v) Waiver of subrogation in favor of SWACO and all related entities or subsidiaries, employees, agents, and/or representatives

b) *Automobile Liability Insurance*, containing a limit of \$1,000,000.00 per occurrence.

c) *Worker's Compensation and Employer's Liability Insurance*, containing the following limits:

- (i) Statutory Limits for the State of Ohio
- (ii) \$500,000./\$500,000./\$500,000. Employer's Liability Limit

d) *Umbrella Liability Insurance* containing the following limits and terms:

- (i) Umbrella Liability Insurance containing the limit of \$2,000,000.00 per occurrence and terms including the following "form coverage."

e) Professional Liability Insurance covering errors, omissions, and/or negligence of the Advisor with a coverage limit of \$5,000,000.00.

e) **The limits set forth above may be adjusted according to industry standards, risk, and further assurances.**

f) Each policy of insurance required to be purchased and maintained by the Successful Proposer shall be purchased from an insurance carrier rated by A.M. Best as A-, VII or better;

g) Each policy and respective certificate of insurance shall expressly provide that should the Successful Proposer's insurance lapse, be cancelled, non-renewed or materially altered, the Successful Proposer shall provide SWACO with no less than thirty (30) days prior written notice of such cancellation, non-renewal, expiration or material alteration of the coverage contained in such policy or evidenced by such certificate of insurance.

e) The Successful Proposer shall maintain all insurance in the required amounts, without interruption, from the date of the execution of the contract until the date of the termination of the contract or the date of payment of the final invoice issued by Successful Proposer, whichever is later. Failure of the Successful Proposer to comply with the terms and conditions of this paragraph shall constitute a material breach of the contract and shall be cause for termination of this Contract by SWACO.

f) Insurance policies required to be purchased and maintained by the Successful Proposer may include a reasonable loss deductible, as is customary for the Successful Proposer's industry, which shall be the sole responsibility of the Successful Proposer to pay in the event of any covered loss.

5. SWACO and the Successful Proposer waive all rights against each other for damages caused by fire or other perils to the extent of actual recovery of any insurance proceeds under any property insurance obtained pursuant to the requirements set forth above or any other property insurance applicable to the performance of the Services, except such rights as they have to proceeds of such insurance held by SWACO as fiduciary. The Successful Proposer agrees to obtain waivers in favor of SWACO of such claims by all of its subcontractors.

6. Notwithstanding the paragraph above, and regardless of the amount of any insurance proceeds recovered by the parties under the insurance policies set forth above, the Successful Proposer shall be liable to SWACO for the full amount of any claims, damages, losses, liens, causes of action, suits, judgments, and expenses (including reasonable attorney's fees and other reasonable costs of defense) of any nature, kind or description which are in excess of such insurance proceeds.

VII. Applicable Law

A. Venue. The terms, provisions and conditions as set forth in this RFQ, the submission and evaluation of any SOQs submitted in response to this RFQ, the negotiation, award, execution, and construction of the terms, conditions, provisions, and the scope of services of any contract resulting from this RFQ, and all other matters or claims related to this RFQ and/or any contract resulting from this RFQ shall be solely governed by, and construed in accordance with, the laws of the State of Ohio without regard to its choice of law provisions and to the

exclusion of the law of any other jurisdiction. Any action, claim, suit, or proceeding related to this RFQ or any contract resulting from this RFQ shall be brought only in a court having appropriate jurisdiction and venue in Franklin County, Ohio.

B. Non-Discrimination. Proposers shall not discriminate against any employee or qualified applicant for employment who is both available and qualified for work because of age, race, color, religion, sex, disability, creed, military status, or national origin. Proposers shall not discriminate based upon age, race, color, religion, sex, disability, creed, military status or national origin in any undertaking related to employment including, but not limited to, such actions as hiring, upgrading, demotion or transfer, recruitment or recruitment advertising, layoff or termination, rates of pay or other forms of compensation, and selection for training, including apprenticeship.

C. Public Records. All Proposers are advised that SOQs received by SWACO in response to this RFQ may constitute public records as defined by Ohio Revised Code Section 149.43 and any additional information submitted by Proposer pursuant to this RFQ shall become the property of SWACO. However, if there is material in an SOQ that a Proposer deems to be confidential or a trade secret as defined in Ohio Revised Code Section 1333.61, it should be clearly identified as such, marked confidential, or if a trade secret marked as a trade secret, and accompanied by a written explanation stating the basis of such claim. Any confidential or trade secret material that is properly designated shall be removed from the SOQ prior to release of the SOQ to the public if permitted by the laws of the State of Ohio including, without limitation, Ohio Revised Code Section 149.43. The determination as to the confidentiality of any material identified as confidential or a trade secret by a Proposer shall be made by SWACO in SWACO's sole and complete discretion. SWACO shall assume no risk, nor shall it be held liable by any Proposer for the release of any material which Proposer may claim to be confidential or a trade secret. Submittal by Proposer of an SOQ to SWACO shall be deemed acknowledgement of the terms and provisions contained in this paragraph C.

VIII. Statement of Qualifications Evaluation

A. Evaluation Criteria. SOQs shall be evaluated based upon the Proposer's ability to meet the requirements set forth in this RFQ, as stated in the submitted SOQ, any clarifications that SWACO may request from individual Proposers, and the criteria below.

SWACO reserves the right to give each of the following criteria such weight as it deems appropriate in its sole and complete discretion:

1. The Proposer's ability to perform the proposed scope of services;
2. Proposer's experience and the quality of its available services;
3. The Proposer's understanding of SWACO's requirements as expressed in the RFQ; and
4. Proposer's personnel, implementation team, and subcontractors based on the information set forth in this RFQ.

B. Evaluation of SOQs. SWACO's Executive Director or designee shall appoint an Evaluation Committee ("Committee") to evaluate the SOQs received. The Committee shall evaluate all SOQs received and rank the Proposers based upon the evaluation criteria set forth above in paragraph A, and the responsiveness to the RFQ requirements. SWACO reserves the right to request additional information from Proposers as needed. If such

information is requested, the Committee is not required, at this stage of the evaluation process, to request the same information from all Proposers.

1. The Committee may, at its sole and complete discretion, select two (2) or more of the highest qualified Proposers with which to hold additional discussions. Proposers not selected for further discussions may be excluded from further consideration for the contract to be awarded through this RFQ upon notification by the Committee and/or SWACO's Executive Director or designee.

2. Additional discussions with selected Proposers indicated above may include, without limitation, discussions, interviews, and presentations by the selected Proposer(s) to SWACO to elaborate upon their qualifications, proposed services, and other pertinent information. During the "additional discussions phase" the Committee may permit revisions of SOQs. In such an event, all Proposers who have been selected for additional discussions shall be given an equal opportunity to revise their SOQs.

3. SWACO shall then rank the SOQs that have not been otherwise excluded from further consideration based upon the evaluation requirements set forth in this RFQ, the content of the SOQs received, any revisions thereto, and any additional discussions with the Proposers that may have been held by the Committee and any non-excluded Proposers.

C. Notifications. All Proposers submitting a response to this RFQ will be notified upon final determination of the Successful Proposer(s) selected to perform the Project.

IX. Awarding the Contract

A. Information Provided to Successful Proposer. SWACO shall provide to the Successful Proposer(s), upon request, any information concerning the Project to which it has access. SWACO may, at its sole option, provide information to the Successful Proposer(s) in electronic format.

B. Negotiation and Award of Contract. After non-excluded Proposers have been ranked pursuant to Section VIII above, SWACO's Executive Director or designee shall enter into contract negotiations with the highest ranked Successful Proposer. If negotiations between such highest ranked Successful Proposer and SWACO's Executive Director or designee fail to result in a contract between SWACO and that Successful Proposer, those negotiations shall be terminated, and the Executive Director or designee may enter into contract negotiations with the next highest ranked Successful Proposer. Such process may continue until a contract has been successfully negotiated between SWACO and a Successful Proposer or until there are no Proposers left in which to hold contract negotiations.

1. Negotiations shall cover such terms, provisions, conditions, scope of services and other matters as the parties deem appropriate to attain the objectives of the Project contemplated in this RFQ.

2. At SWACO's sole and complete discretion, SWACO may terminate contract negotiations with a Successful Proposer and begin contract negotiations with the next highest ranked Proposer.

3. At any time prior to the execution of a contract by SWACO's Executive Director, SWACO's Executive Director may cancel or terminate the process set forth in this RFQ for any or no reason.

4. No contract negotiated between SWACO and the Successful Proposer shall become effective until the terms, conditions, provisions, and services negotiated between SWACO and the Successful Proposer have been reduced to a written contract, and the resulting contract has been executed by the Successful Proposer and SWACO's Executive Director as authorized by SWACO's procurement policy.
- C. Contract Execution. Any contract awarded shall be signed by the Successful Proposer and returned within thirty (30) days after the Successful Proposer has received the "Notice of Award" and negotiated contract for signature.
1. No contract resulting from negotiations with the Successful Proposer or from the process set forth in this RFQ shall be considered binding upon SWACO until execution of the contract by the Successful Proposer and SWACO's Executive Director pursuant to SWACO's procurement policy.
 2. If the Successful Proposer fails to execute and return the contract and other required documents within thirty (30) days of the receipt of the Notice of Award, SWACO may, in its sole and complete discretion, either withdraw the award of the contract to the Successful Proposer and begin negotiations with the next highest ranked Proposer pursuant to the terms, conditions, and provisions set forth in this RFQ or in the alternative, terminate the process set forth in this RFQ.

Foreign person. Nonresident alien who becomes a resident alien. Generally, only a nonresident alien individual may use the terms of a tax treaty to reduce or eliminate U.S. tax on certain types of income. However, most tax treaties contain a provision known as a saving clause. Exceptions specified in the saving clause may permit an exemption from tax to continue for certain types of income even after the payee has otherwise become a U.S. resident alien for tax purposes.

If you are a U.S. resident alien who is relying on an exception contained in the saving clause of a tax treaty to claim an exemption from U.S. tax on certain types of income, you must attach a statement to Form W-9 that specifies the following five items.

1. The treaty country. Generally, this must be the same treaty under which you claimed exemption from tax as a nonresident alien.
2. The treaty article addressing the income.
3. The article number (or location) in the tax treaty that contains the saving clause and its exceptions.
4. The type and amount of income that qualifies for the exemption from tax.
5. Sufficient facts to justify the exemption from tax under the terms of the treaty article.

Example. Article 20 of the U.S.-China income tax treaty allows an exemption from tax for scholarship income received by a Chinese student temporarily present in the United States. Under U.S. law, this student will become a resident alien for tax purposes if their stay in the United States exceeds 5 calendar years. However, paragraph 2 of the first Protocol to the U.S.-China treaty (dated April 30, 1984) allows the provisions of Article 20 to continue to apply even after the Chinese student becomes a resident alien of the United States. A Chinese student who qualifies for this exception (under paragraph 2 of the first Protocol) and is relying on this exception to claim an exemption from tax on their scholarship or fellowship income would attach to Form W-9 a statement that includes the information described above to support that exemption.

If you are a nonresident alien or a foreign entity, give the requester the appropriate completed Form W-8 or Form 8233.

Backup Withholding

What is backup withholding? Persons making certain payments to you must under certain conditions withhold and pay to the IRS 24% of such payments. This is called “backup withholding.” Payments that may be subject to backup withholding include, but are not limited to, interest, tax-exempt interest, dividends, broker and barter exchange transactions, rents, royalties, nonemployee pay, payments made in settlement of payment card and third-party network transactions, and certain payments from fishing boat operators. Real estate transactions are not subject to backup withholding.

You will not be subject to backup withholding on payments you receive if you give the requester your correct TIN, make the proper certifications, and report all your taxable interest and dividends on your tax return.

Payments you receive will be subject to backup withholding if:

1. You do not furnish your TIN to the requester;
2. You do not certify your TIN when required (see the instructions for Part II for details);
3. The IRS tells the requester that you furnished an incorrect TIN;
4. The IRS tells you that you are subject to backup withholding because you did not report all your interest and dividends on your tax return (for reportable interest and dividends only); or
5. You do not certify to the requester that you are not subject to backup withholding, as described in item 4 under “*By signing the filled-out form*” above (for reportable interest and dividend accounts opened after 1983 only).

Certain payees and payments are exempt from backup withholding. See *Exempt payee code*, later, and the separate Instructions for the Requester of Form W-9 for more information.

See also *Establishing U.S. status for purposes of chapter 3 and chapter 4 withholding*, earlier.

What Is FATCA Reporting?

The Foreign Account Tax Compliance Act (FATCA) requires a participating foreign financial institution to report all U.S. account holders that are specified U.S. persons. Certain payees are exempt from FATCA reporting. See *Exemption from FATCA reporting code*, later, and the Instructions for the Requester of Form W-9 for more information.

Updating Your Information

You must provide updated information to any person to whom you claimed to be an exempt payee if you are no longer an exempt payee and anticipate receiving reportable payments in the future from this person. For example, you may need to provide updated information if you are a C corporation that elects to be an S corporation, or if you are no longer tax exempt. In addition, you must furnish a new Form W-9 if the name or TIN changes for the account, for example, if the grantor of a grantor trust dies.

Penalties

Failure to furnish TIN. If you fail to furnish your correct TIN to a requester, you are subject to a penalty of \$50 for each such failure unless your failure is due to reasonable cause and not to willful neglect.

Civil penalty for false information with respect to withholding. If you make a false statement with no reasonable basis that results in no backup withholding, you are subject to a \$500 penalty.

Criminal penalty for falsifying information. Willfully falsifying certifications or affirmations may subject you to criminal penalties including fines and/or imprisonment.

Misuse of TINs. If the requester discloses or uses TINs in violation of federal law, the requester may be subject to civil and criminal penalties.

Specific Instructions

Line 1

You must enter one of the following on this line; **do not** leave this line blank. The name should match the name on your tax return.

If this Form W-9 is for a joint account (other than an account maintained by a foreign financial institution (FFI)), list first, and then circle, the name of the person or entity whose number you entered in Part I of Form W-9. If you are providing Form W-9 to an FFI to document a joint account, each holder of the account that is a U.S. person must provide a Form W-9.

• **Individual.** Generally, enter the name shown on your tax return. If you have changed your last name without informing the Social Security Administration (SSA) of the name change, enter your first name, the last name as shown on your social security card, and your new last name.

Note for ITIN applicant: Enter your individual name as it was entered on your Form W-7 application, line 1a. This should also be the same as the name you entered on the Form 1040 you filed with your application.

• **Sole proprietor.** Enter your individual name as shown on your Form 1040 on line 1. Enter your business, trade, or “doing business as” (DBA) name on line 2.

• **Partnership, C corporation, S corporation, or LLC, other than a disregarded entity.** Enter the entity’s name as shown on the entity’s tax return on line 1 and any business, trade, or DBA name on line 2.

• **Other entities.** Enter your name as shown on required U.S. federal tax documents on line 1. This name should match the name shown on the charter or other legal document creating the entity. Enter any business, trade, or DBA name on line 2.

• **Disregarded entity.** In general, a business entity that has a single owner, including an LLC, and is not a corporation, is disregarded as an entity separate from its owner (a disregarded entity). See Regulations section 301.7701-2(c)(2). A disregarded entity should check the appropriate box for the tax classification of its owner. Enter the owner’s name on line 1. The name of the owner entered on line 1 should never be a disregarded entity. The name on line 1 should be the name shown on the income tax return on which the income should be reported. For

example, if a foreign LLC that is treated as a disregarded entity for U.S. federal tax purposes has a single owner that is a U.S. person, the U.S. owner’s name is required to be provided on line 1. Line 3b

Check this box if you are a partnership (including an LLC classified as a partnership for U.S. federal tax purposes), trust, or estate that has any foreign partners, owners, or beneficiaries, and you are providing this form to a partnership, trust, or estate, in which you have an ownership interest. You must check the box on line 3b if you receive a Form W-8 (or documentary evidence) from any partner, owner, or beneficiary establishing foreign status or if you receive a Form W-9 from any partner, owner, or beneficiary that has checked the box on line 3b.

Privacy Act Notice

CONTRACT FOR PROFESSIONAL SERVICES

This Agreement is by and between the Solid Waste Authority of Central Ohio, ("SWACO"), a regional solid waste district established pursuant to Ohio Revised Code Section 343.011 with a business address of 4239 London-Groveport Road, Grove City, Ohio 43123, and [SUCCESSFUL PROPOSER] ("Contractor"), located at [SUCCESSFUL PROPOSER ADDRESS].

NOW, THEREFORE, in consideration of the mutual promises herein contained, SWACO and Contractor agree as follows:

1. Term. The term of this Agreement shall commence on [START DATE] and shall terminate on [END DATE]. For multi-year contracts, SWACO's funds are contingent upon the approval of the annual budget by the Board of Trustees. If SWACO's Board of Trustees fails at any time to continue funding for the payments or any other obligations due by SWACO under this Contract, SWACO will be released from its obligations on the date the funding expires. This Contract may be terminated by SWACO for any or no reason upon delivery by first class U.S. mail, postage prepaid, or delivery by hand, of a written "Notice of Termination" to Contractor at least fifteen (15) days prior to the date of the intended early termination of this Contract.

1.1. *Non-Exclusivity of Contract*. Contractor understands and agrees that this Contract for the provision of Services is not intended to be, nor shall it be construed to be, an exclusive Contract with SWACO for the provision of the type of Services set forth in this Contract.

1.2. *Level of Services Requested*. SWACO is not required by this Contract to request any Services, or a minimum amount of Services, from Contractor.

2. Scope of Services. Contractor shall provide all services in accordance with the terms, conditions, and provisions as set forth in this Contract, the Request for Qualifications attached hereto as Exhibit A, Contractor's Statement of Qualifications attached hereto as Exhibit B, and Rates attached hereto as Exhibit C, all of which are incorporated herein by reference as if fully rewritten (collectively "Services"). Contractor shall perform all Services in accordance with the terms, conditions, and provisions set forth in this Contract and the attached exhibit(s).

2.1. *Standard of Care*. Contractor shall perform all Services in accordance with professional standards of skill, care, and diligence for Contractor's profession and in accordance with pertinent provisions of the Ohio Revised Code, the Ohio Administrative Code, federal and/or local statutes, ordinances, rules, and regulations.

2.2. *Acceptance or Rejection of Services*. SWACO may, in its sole and complete discretion, accept or reject any portion of the Services provided by Contractor. In the event that any portion of the Services is rejected by SWACO, Contractor shall proceed, upon SWACO's request, with correcting any such rejected Services to the reasonable satisfaction of SWACO. The review or acceptance by SWACO of any Services performed by Contractor pursuant to this Contract shall not relieve Contractor of its responsibility to perform such Services pursuant to the terms and conditions of this Contract.

3. Contractor Compensation. Pursuant to the Rates set forth in Exhibit C and as mutually agreed upon by the Parties in writing, SWACO shall pay Contractor for the Services performed in an amount not to exceed [AMOUNT] dollars (\$###.##). Compensation shall be inclusive of all costs associated with Contractor providing Services.

3.1. Upon delivery and completion of any Service and acceptance by SWACO, Contractor shall submit to SWACO an invoice setting forth the date that the Services were rendered, a description and unit costs of the Services provided, and the total amount of compensation sought.

3.2. All invoices should be submitted to SWACO within sixty (60) days after Services have been rendered and shall state SWACO's project and purchase order numbers, both of which are set forth on page one (1) of this Contract. SWACO shall pay such invoice within thirty (30) days of its approval by SWACO. However, regardless of when payment is made, and notwithstanding any terms set forth on the invoice and/or any other document to the contrary, SWACO shall never be obligated or liable to Contractor and/or any other party for any late payment or collection costs, fees, or interest charges.

3.3 Notwithstanding any term, condition, or provision set forth in this Contract and/or any other document to the contrary, the total monetary obligation of SWACO under this Contract shall never exceed the total sum of [AMOUNT] dollars (\$###.##).

4. General Duty to Indemnify SWACO. Contractor shall indemnify and hold harmless SWACO, its Trustees, officers, employees and representatives from and against all claims, damages, losses, liens, causes of action, suits, judgments, and expenses, including reasonable attorney's fees and other reasonable costs of defense, of any nature, kind, or description, which (a) are caused by or result from the performance of the Services by Contractor, anyone directly or indirectly employed by Contractor, any subcontractor, or anyone for whose acts Contractor is legally liable, and (b) are attributable to bodily injury, personal injury, sickness, disease, or death of any person, or to damage to or destruction of property, but (c) only to the extent they are caused by any negligent, reckless, or willful act, error, or omission of Contractor, anyone directly or indirectly employed by Contractor, any subcontractor, or anyone for whose acts Contractor is legally liable. The terms, conditions, and provisions of this paragraph shall survive the termination of this Contract for any reason.

4.1. *Correction, Repair or Replacement of Insured Losses.* Contractor shall promptly correct, repair, and/or replace any items, work, and/or materials installed as part of the Services and damaged and/or destroyed as a result of an insured loss or damage. Such correction, repair, and/or replacement shall be Contractor's sole responsibility and shall be undertaken and completed at no additional cost to SWACO.

5. Entire Contract. This Contract and the attached exhibit(s) represent the entire and integrated contract between SWACO and Contractor and supersede all prior negotiations, representations, agreements, or contracts, either written or oral, between the parties hereto.

6. Effect of Captions. The captions or headings in this Contract are for convenience only and in no way define, limit, or describe the scope or intent of any terms, conditions, provisions, or sections hereof.

7. No Personal Liability of SWACO Officials. Neither SWACO's Board of Trustees, either individually or collectively, nor any SWACO official executing this Contract or any modification hereto shall be subject to any personal liability by reason of such execution.
8. Contract Binding on Successors and Assigns. SWACO and Contractor each bind themselves, their successors, assigns, and legal representatives to the other party to this Contract.
9. No Third-Party Interest. No person or corporation other than Contractor and SWACO have any interest hereunder and no claim shall be made or be valid, nor shall any term, condition, provision, or covenant herein be construed so as to give any person other than the parties hereto any legal or equitable right, remedy, or claim under or in respect to this Contract.
10. Assignment by Contractor. Contractor shall not assign or transfer any right, title, or interest in this Contract without the prior written consent of SWACO, which consent may be withheld by SWACO for any or no reason.
11. Confidentiality. Contractor recognizes that it has a fiduciary responsibility to SWACO with respect to the performance under this contract, and that this Contract establishes a confidential relationship between Contractor and SWACO. Accordingly, all Services, including reports, opinions, and information, to be furnished under this Contract are confidential and Contractor shall not divulge such information and/or data, in whole or in part, to any person, other than to duly authorized representatives of SWACO, except by testimony under oath in a judicial proceeding or as otherwise required by law. Contractor has the responsibility and shall take all necessary steps to ensure that no member of his/her staff or organization divulges any such information except as may be required by law. All reports, working documents, and other documents, whether finished or unfinished, prepared by Contractor as part of the Services pursuant to this Contract shall become SWACO property. No documents prepared under this Contract shall be made any part of the subject matter of an application for or designation of a copyright made by or on behalf of Contractor or any other person not a party to this Contract unless the prior written consent is obtained from SWACO.
12. Construction of Contract Terms. If any paragraph, term, condition, or provision of this Contract is determined by a court of competent jurisdiction to be invalid or unenforceable, such determination shall not affect the validity or enforceability of any other paragraph, term, condition, or provision of this Contract, each of which shall be construed and enforced to the fullest extent of the law as if such invalid or unenforceable paragraph, term, condition, or provision were not contained herein.
13. Negotiation of Contract Terms, Conditions, and Provisions. The parties acknowledge and recognize that each of them participated materially in the negotiation and drafting of this Contract and had access to legal counsel during its negotiation and drafting.
14. Applicable Law; Venue. The laws of the State of Ohio, without regard to its own "choice of law" provisions, shall govern to the exclusion of the laws of any other jurisdiction in the interpretation and application of the terms, conditions, and provisions of this Contract. Any action or proceeding pertaining to this Contract shall be heard in a court of law having appropriate jurisdiction located in Franklin County, Ohio.

15. Delinquent Tax Affidavit. The Delinquent Tax Affidavit shall be executed contemporaneously by Contractor with the execution of this Contract and is incorporated herein by reference as if fully rewritten. If Contractor fails to submit a fully executed Delinquent Tax Affidavit, SWACO shall be authorized to immediately terminate this Agreement without having to provide fifteen (15) days' notice pursuant to Section 1.

16. Contractor is Independent Contractor. Nothing contained in this Contract is intended to be, or shall be, construed to create or establish the relationship of a partnership, joint venture, or other business organization between the parties hereto nor to create an agency, representative, or employment relationship between Contractor or its employees and SWACO. Neither Contractor nor its employees shall be considered an employee of SWACO, nor shall they acquire or be entitled to any compensation, rights, benefits, and/or participation of any kind whatsoever offered by SWACO including, without limitation, participation in the Ohio Public Employees Retirement System, worker's compensation coverage, and/or benefits, medical, and hospital care, sick, and vacation leave, unemployment compensation, disability, and severance pay. If Contractor is an individual utilizing a personal social security number for tax identification purposes or is a business with four (4) or fewer employees, it must complete and submit the OPERS independent contractor acknowledgment form. This form has been provided to Contractor by SWACO for execution contemporaneously by Contractor with the execution of this Contract, if applicable.

17. Compliance with Law. By executing this Contract, Contractor acknowledges that it is in compliance with all federal, State, municipal, and/or other local laws, ordinances, resolutions, rules, and regulations that govern this Contract and its performance including, without limitation, Ohio Revised Code section 3517.13, divisions (I) and (J).

18. Non-Discrimination. Contractor agrees that during the performance of this Contract, Contractor and any subcontractor shall not discriminate against any employee or qualified applicant for employment who is both available and qualified for work because of age, race, color, religion, sex, disability, creed, military status, or national origin. Contractor and any subcontractor shall not discriminate based upon age, race, color, religion, sex, disability, creed, military status, or national origin in any undertaking related to employment including, but not limited to, such actions as hiring, upgrading, demotion or transfer, recruitment or recruitment advertising, layoff or termination, rates of pay or other forms of compensation, and selection for training, including apprenticeship.

19. Contract Modification. This Contract may only be modified by a writing signed by the Contractor and SWACO's Executive Director. Any other change to the terms and conditions of this Contract will not be legally binding, even if signed by another employee of SWACO, pursuant to SWACO's procurement policy. Additionally, any written modification to the scope of services must also include the impact to the compensation as provided for in Section 3.

20. Employment Taxes. Each party will be solely responsible for reporting, withholding, and/or paying all employment related taxes, payments, and/or withholdings for its own personnel, including, but not limited to, federal, State and local income taxes, social security, unemployment or disability deductions, withholdings, and/or payments, together with any interest and penalties not disputed with the appropriate taxing authority.

21. Sales, Use, Excise, and Property Tax. SWACO is exempt from any sales, use, excise, and property tax. To the extent sales, use, excise, or any similar tax is imposed on Contractor in connection with the provision of Services, such will be the sole and exclusive responsibility of Contractor, and Contractor will pay such taxes, together with any interest and penalties not disputed with the appropriate taxing authority, whether they are imposed at the time the services are rendered or a later time.

22. Drug-Free Workplace. Contractor will comply with all applicable State and federal laws regarding keeping a drug-free workplace. Contractor will make a good faith effort to ensure that all Contractor's employees, while working on SWACO property, will not have or be under the influence of illegal drugs, alcohol, or abuse prescription drugs in any way.

23. Confidential Information Defined. "Confidential Information" shall include, without limitation, information, knowledge, or data (i) of a technical nature such as but not limited to methods, know-how, formulae, compositions, processes, machinery (including computer hardware), discoveries, inventions, products, product specifications, computer software, and similar items or research projects; (ii) of a business nature such as but not limited to information about SWACO, its employees, or its products, costs, purchasing or suppliers, profits, markets, customer lists, customer purchasing and pricing information, distributors, supply costs, and the financial condition of SWACO; (iii) pertaining to future developments such as but not limited to SWACO's strategic planning, research and development, future marketing or merchandising, and trade secrets; and (iv) all other matters that SWACO treats as confidential or that constitute trade secrets as defined in Section 1333.61 of the Ohio Revised Code.

24. Use and Disclosure of SWACO's Confidential Information. Contractor recognizes that this Agreement establishes a confidential relationship between Contractor and SWACO. Accordingly, all services, including reports, opinions, and information, to be furnished under this Agreement are confidential, and Contractor shall not divulge such information and/or data, in whole or in part, to any person, other than to duly authorized representatives of SWACO, except by testimony under oath in a judicial proceeding or as otherwise required by law. Contractor acknowledges that such information is a special, valuable, and unique asset. Contractor agrees to keep and maintain the information in strict confidence and use the information only as authorized by SWACO.

(a) Contractor has the responsibility and shall take all necessary steps to ensure that no member of its staff or organization divulges any such information except as may be required by law.

(b) Contractor will not use the information for the benefit of any third party or use the information other than in performance of services pursuant to this Agreement. Contractor will not disclose any portion of the information to any third party without the prior written permission of SWACO.

(c) All reports, working documents, and other documents, whether finished or unfinished, prepared by Contractor as part of the services pursuant to this Agreement shall become SWACO property. No documents prepared under this Agreement shall be made any part of the subject matter of an application for or designation of a copyright made by or on behalf of Contractor or any other person not a party to this Agreement unless the prior written consent is obtained from SWACO.

- (i) No right or permission is granted in this Agreement to photograph or electronically record any aspect or portion of the information.

25. Use and Disclosure of Contractor's Confidential Information. Pursuant to and subject to Ohio Revised Code, all information submitted to SWACO shall become a record open to the inspection of the public. However, if there is material that Contractor deems to be confidential, it must be clearly identified and marked "CONFIDENTIAL" accompanied by a written explanation stating the basis of such claim. Any confidential material that is properly designated shall be protected and not subject to release to the public if permitted by the laws of the State of Ohio, including, without limitation, Ohio Revised Code §149.43.

- (a) The party claiming trade secret status bears the burden to identify and demonstrate that the material is included in categories of protected information under Ohio Revised Code §149.43 and additionally must take some active steps to maintain its secrecy.
- (b) Contractor shall fully indemnify and hold SWACO harmless against any and all actions, claims, liability, costs, damages, charges, and expenses suffered or incurred in connection with or arising out of SWACO not disclosing information pursuant to Ohio Revised Code §149.43 that Contractor has marked as confidential information.
- (c) SWACO is under no obligation to protect any confidential information which:
 - (i) it can demonstrate by written records was previously known to it;
 - (ii) is now, or becomes in the future, public knowledge other than through its own acts or omissions;
 - (iii) it independently develops by those not having access to the confidential information and which can be proven through verifiable records;
 - (iv) it lawfully obtains from sources independent of Contractor; or,
 - (v) is required by applicable law, including the State of Ohio public records laws, to be disclosed.
- (d) SWACO shall assume no risk, nor shall it be held liable by Contractor, for the release of any material that Contractor may claim to be confidential.
- (e) In the event that the disclosure is required by or requested pursuant to applicable law, regulation, stock exchange rule, or legal process to disclose information, SWACO shall, to the extent practical and permitted by law, provide Contractor with written notice of such demand or requirement for disclosure so that Contractor may object to the disclosure and seek to protect its material and/or waive compliance with the terms of this Agreement. In the event that a protective order or other remedy is not obtained, or Contractor waives compliance with the provisions hereof, the determination as to the confidentiality of any material shall be made by SWACO, in its sole and complete discretion. SWACO shall assume no risk, nor shall it be held liable by the Contractor, for the release of any such material.

26. Return or Destruction of Confidential Information. Upon the written request of a Party ("Requesting Party"), the receiving Party ("Receiving Party") shall, at its option, either promptly destroy or return to the Requesting Party, without retaining any copies except to the extent prohibited or required by applicable law, including any retention periods for public entities, all tangible confidential information of the Requesting Party furnished or made available on its behalf to the

Receiving Party or its representatives, provided that the Receiving Party shall not be required to purge any electronic storage or archival media.

27. SWACO Representations As to Subject Matter. All advertisements are accepted and published entirely on the representation that SWACO, or its designee, is authorized to publish the entire contents and subject matter thereof, and it is neither unlawful nor violates the rights of any person.

28. Limitation of Liability for Advertisement Services. This Contract shall not be invalidated for typographical errors, incorrect insertions, or omissions in advertising published. In such event, Contractor agrees to run corrective advertisement or credit SWACO for that portion of the first insertion which may have been rendered valueless by such typographical error, wrong insertion, or omission not resulting from the fault of SWACO. If the advertisement is ordered for more than one insertion, SWACO shall notify Contractor of such error in time for correction before the second insertion.

29. Ownership. All advertising copy which solely represents the creative effort of Contractor and/or the utilization of creativity, illustrations, labor, composition, or material furnished by it, is and remains the property of Contractor, including the right of copyright therein. SWACO understands and agrees that it cannot authorize photographic or other reproductions, in whole or in part, or any such advertising copy for use in any other medium without the express written consent of Contractor.

(a) Discloser. Any advertising that may be mistaken by a reader as news, feature, or other non-advertising content will be clearly marked as "Advertisement."

30. No Waiver. Either party's failure to enforce any provision or term of this Contract shall not be construed as a future or continuing waiver of such provision or term of this Contract.

31. Additional Terms and Conditions. If SWACO and Contractor have included additional terms and conditions specific to this Contract, they are set forth and described in the attached exhibit(s) and incorporated herein by reference as if fully rewritten. In the event of a conflict between the exhibit(s) and the standard terms and conditions provided in Section 1 through Section 34, the standard terms, and conditions in Sections 1 through 34 shall prevail.

32. Authority. The signatories to this Agreement hereby represent and warrant that they have the full power and authority to execute this Agreement and to bind the respective parties to this Agreement, as well as the terms, conditions and obligations set forth herein.

33. Signatures. The parties agree that facsimile, electronic, or scanned signatures shall be acceptable and shall have the same effect as original signatures.

34. Effective Date. This Contract shall become effective on the date provided above.
